FIRST ORDER OF BUSINESS

Call to Order

Mr. Rodriguez called the meeting to order and performed roll call.

SECOND ORDER OF BUSINESS

THIRD ORDER OF BUSINESS

Staff Reports

A. Landscaping Update

Mr. Skokanic provided a landscape update to the Board. A discussion ensued regarding various maintenance issues. i. Presentation of Waterway Inspection Report
